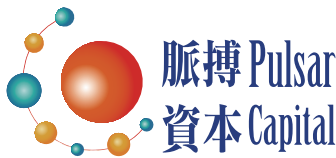

ANNOUNCEMENT OF OFFER PRICE AND ALLOTMENT RESULTS

SUMMARY

Offer Price and Net Proceeds from the Share Offer

- The Offer Price has been determined at HK\$0.40 per Offer Share (excluding brokerage of 1%, SFC transaction levy of 0.0027% and Stock Exchange trading fee of 0.005%).
- Based on the Offer Price of HK\$0.40 per Offer Share and the total number of 120,000,000 Offer Shares, the net proceeds from the Share Offer to be received by the Company, after deducting the underwriting fees and estimated expenses payable by the Company in connection with the Share Offer, are estimated to be approximately HK\$23.5 million. The Company intends to apply such net proceeds in the manner set out in the paragraph headed “Net proceeds from the Share Offer” below in this announcement and the section headed “Future Plans and Use of Proceeds” in the Prospectus.

Application under the Public Offer

- The Public Offer Shares initially offered under the Public Offer have been significantly oversubscribed. A total of 7,509 valid application have been received pursuant to the Public Offer on **WHITE** and **YELLOW** Application Forms, by giving **electronic application instructions** to **HKSCC** via CCASS and to the **HK eIPO White Form** Service Provider through the **HK eIPO White Form** service for a total of 172,850,000 Public Offer Shares, representing approximately 14 times of the total number of 12,000,000 Public Offer Shares initially available for subscription under the Public Offer.
- The over-subscription in the Public Offer is less than 15 times of the total number of Public Offer Shares initially available under the Share Offer, no reallocation mechanism as described in the paragraph headed “Structure and Conditions of the Share Offer – The Public Offer – Reallocation” of the Prospectus has been applied.
